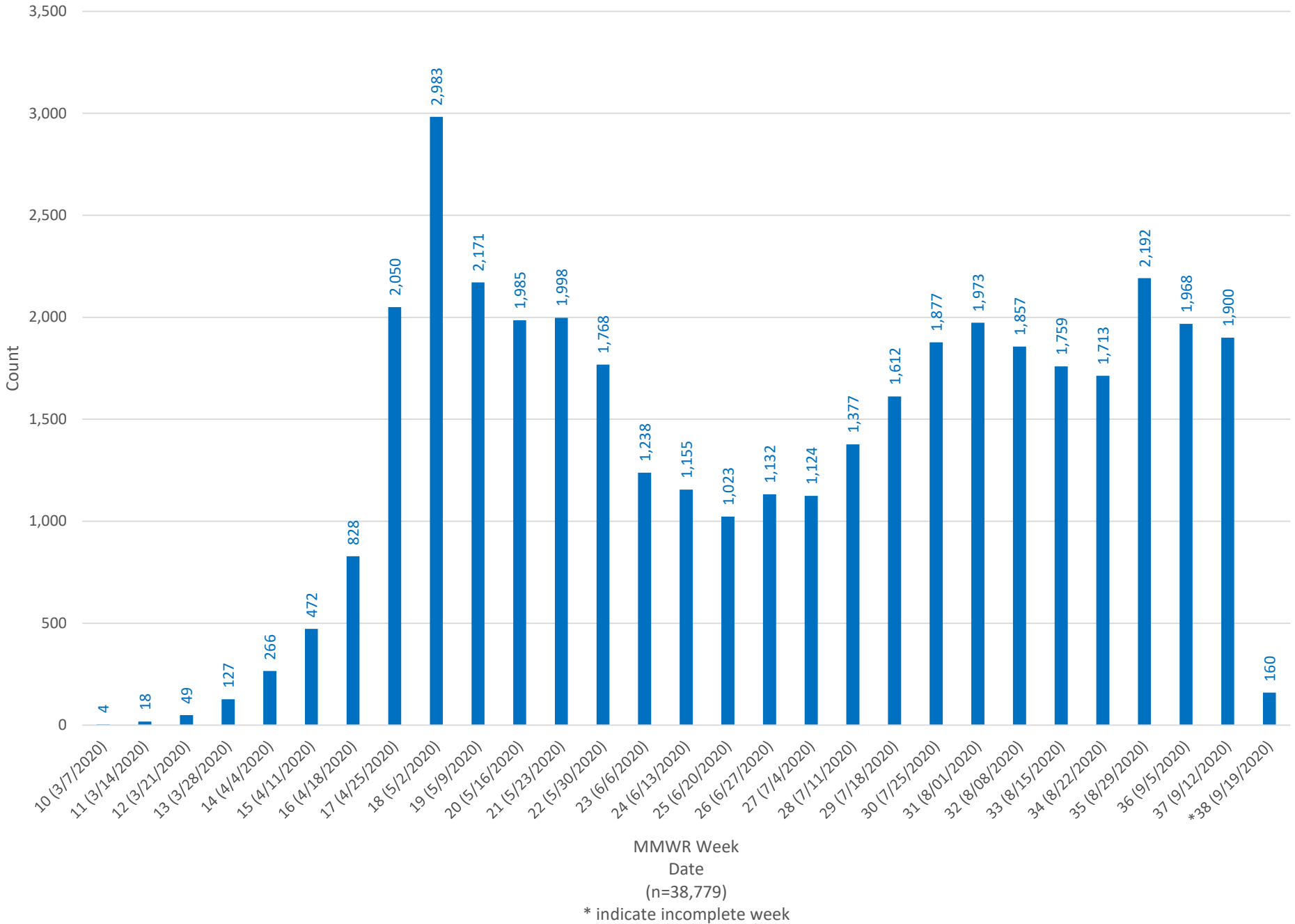

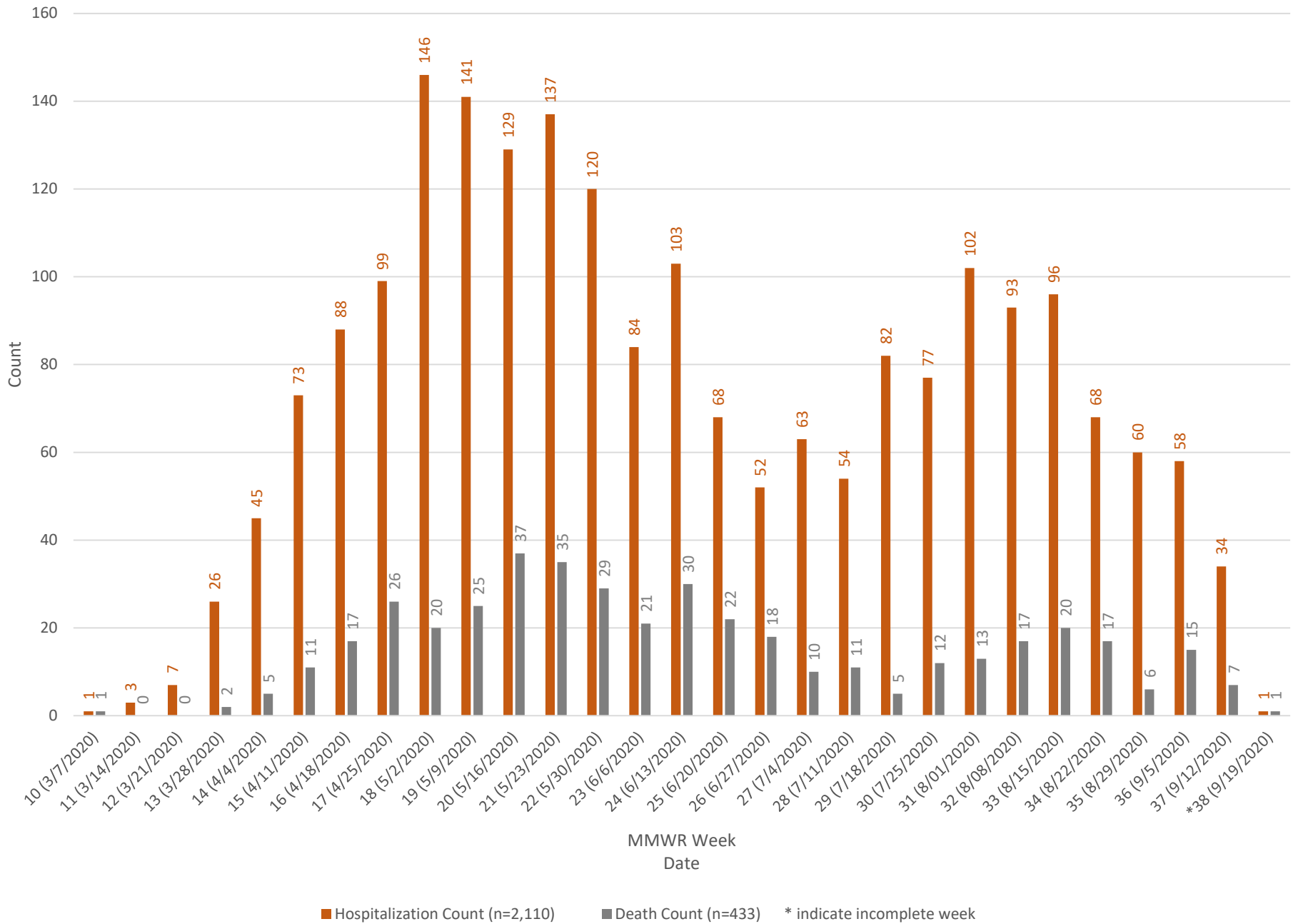

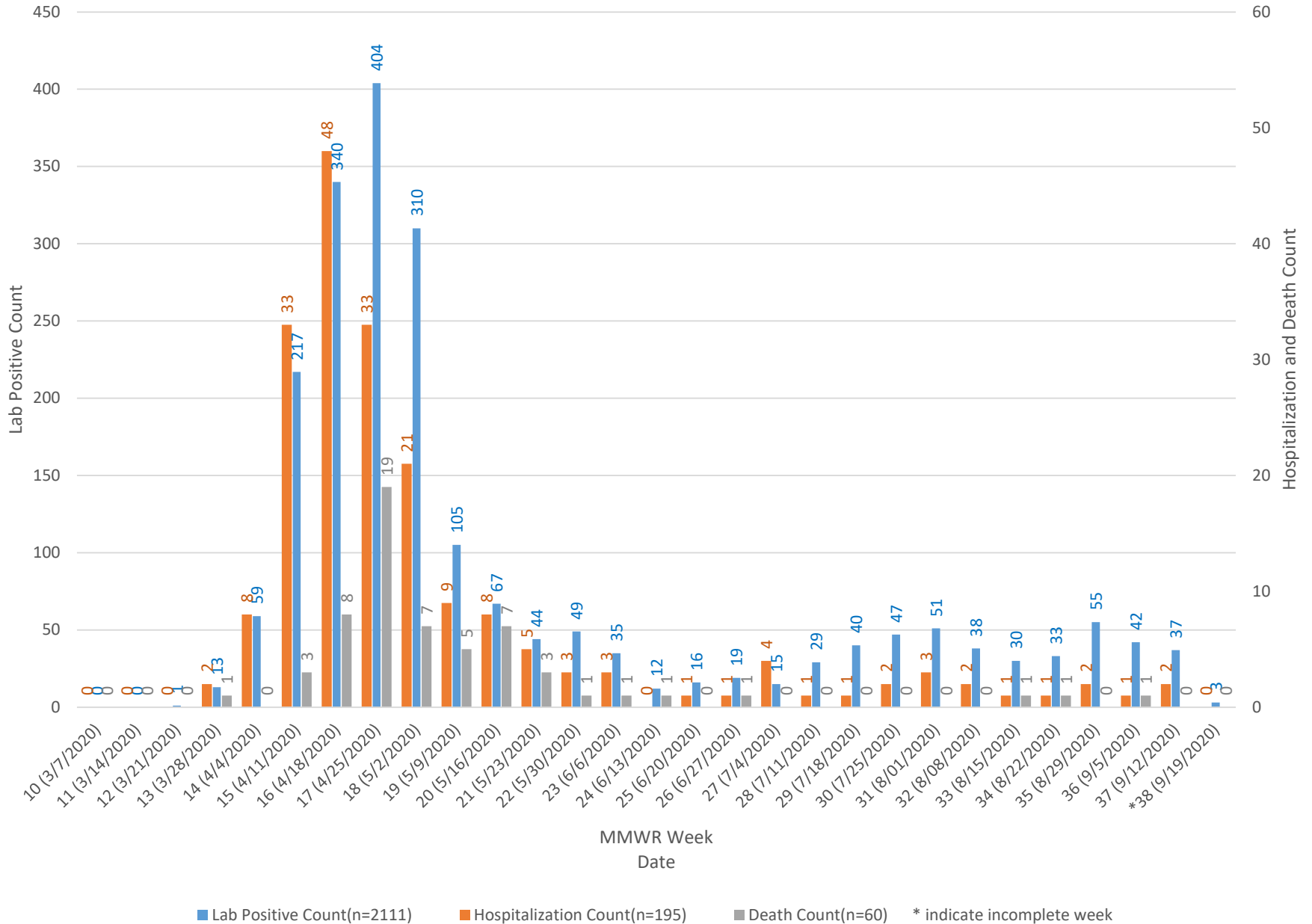

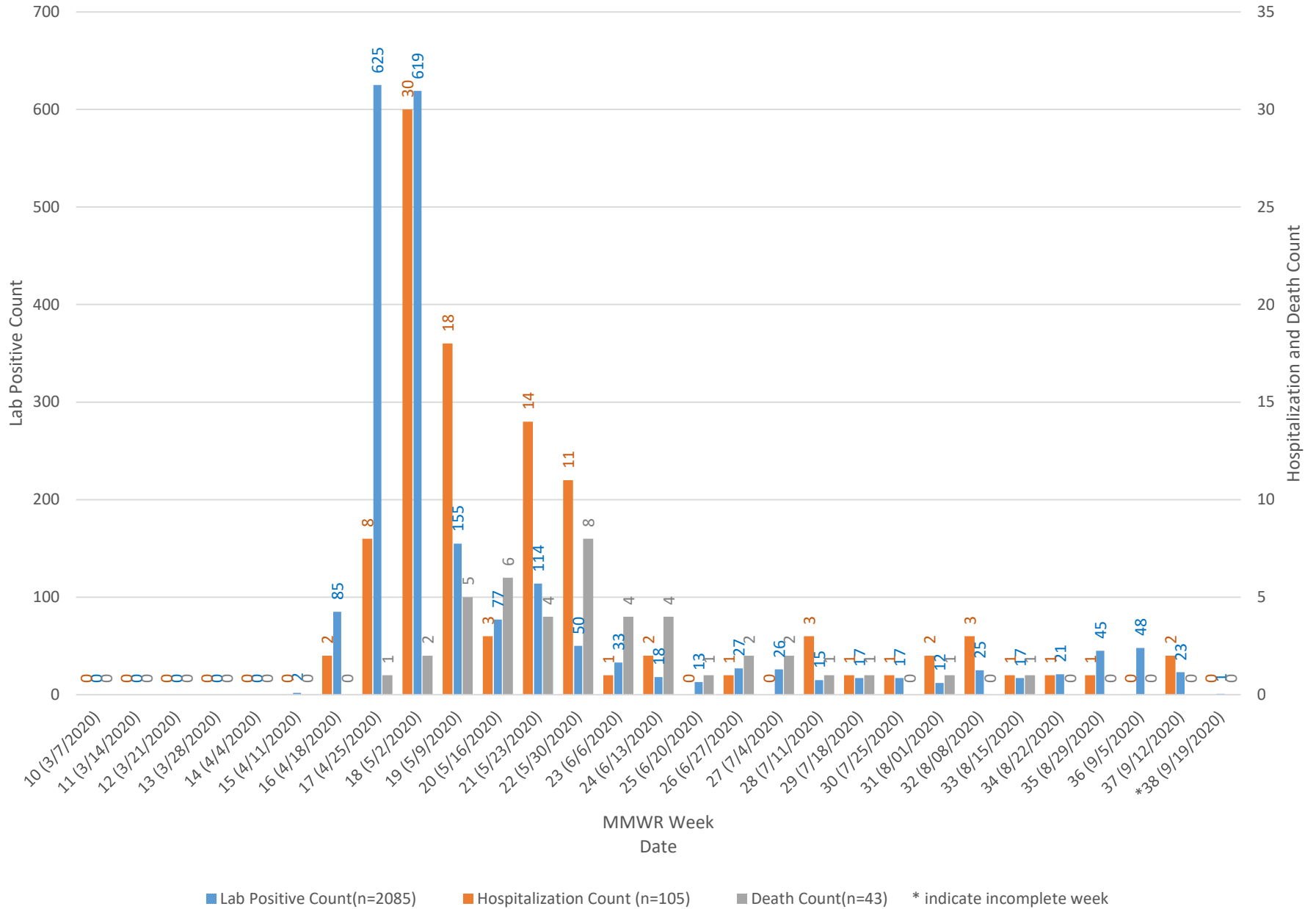
COVID-19 Hospitalization and Death Count by MMWR Week, Nebraska, September 15, 2020



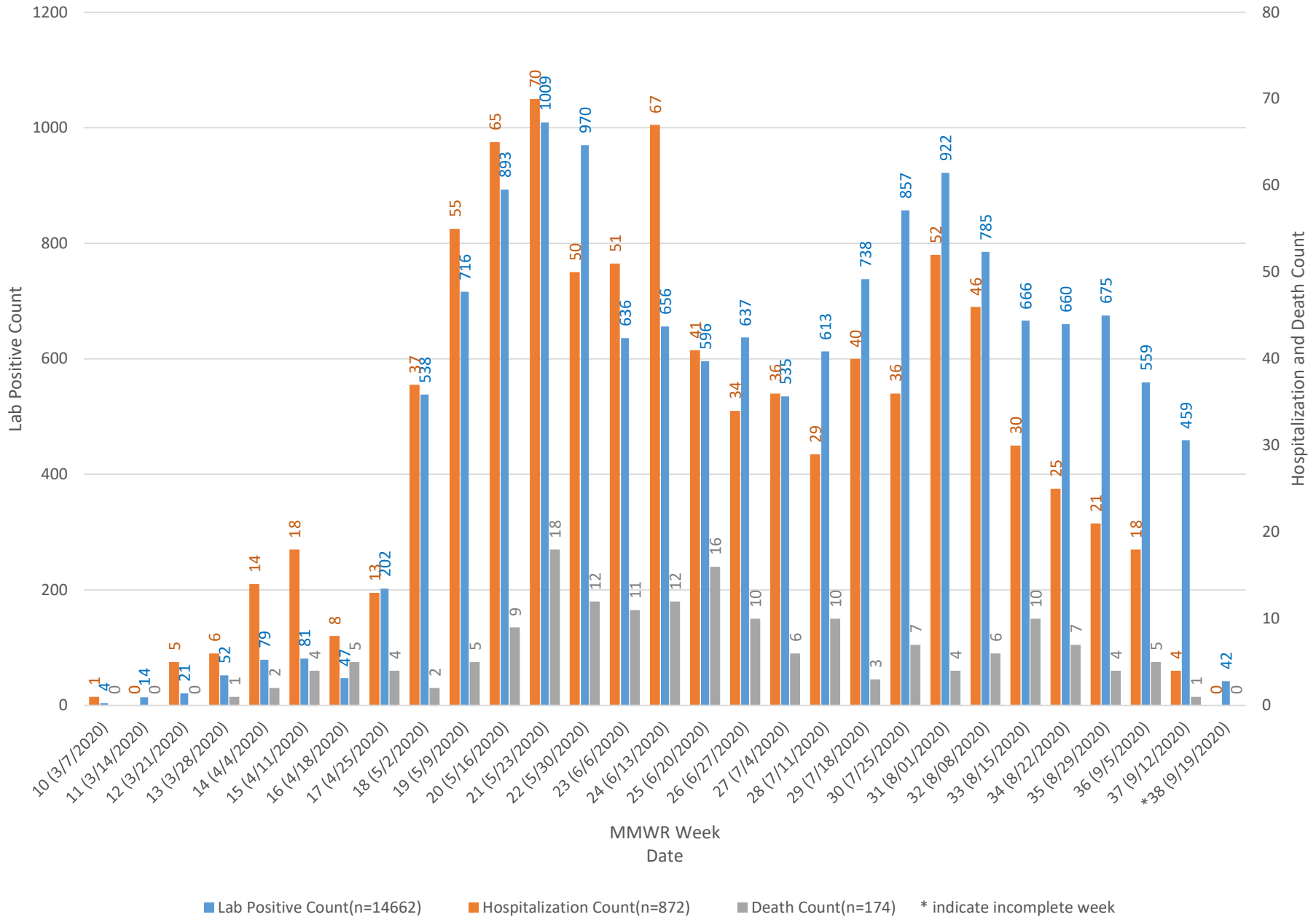
COVID-19 Lab Positive, Hospitalization and Death Count by MMWR Week, Central District Health Department, September 15, 2020



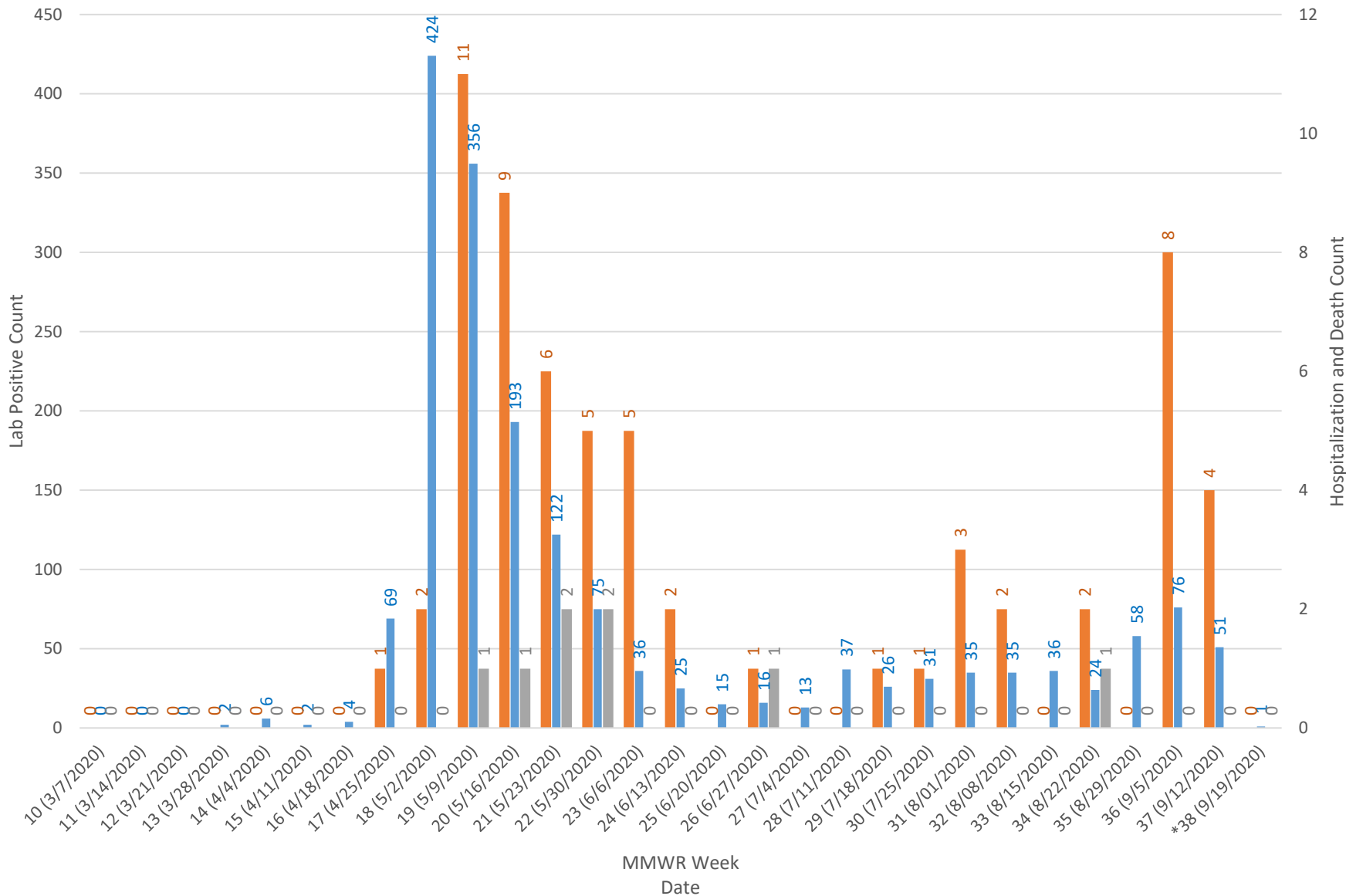

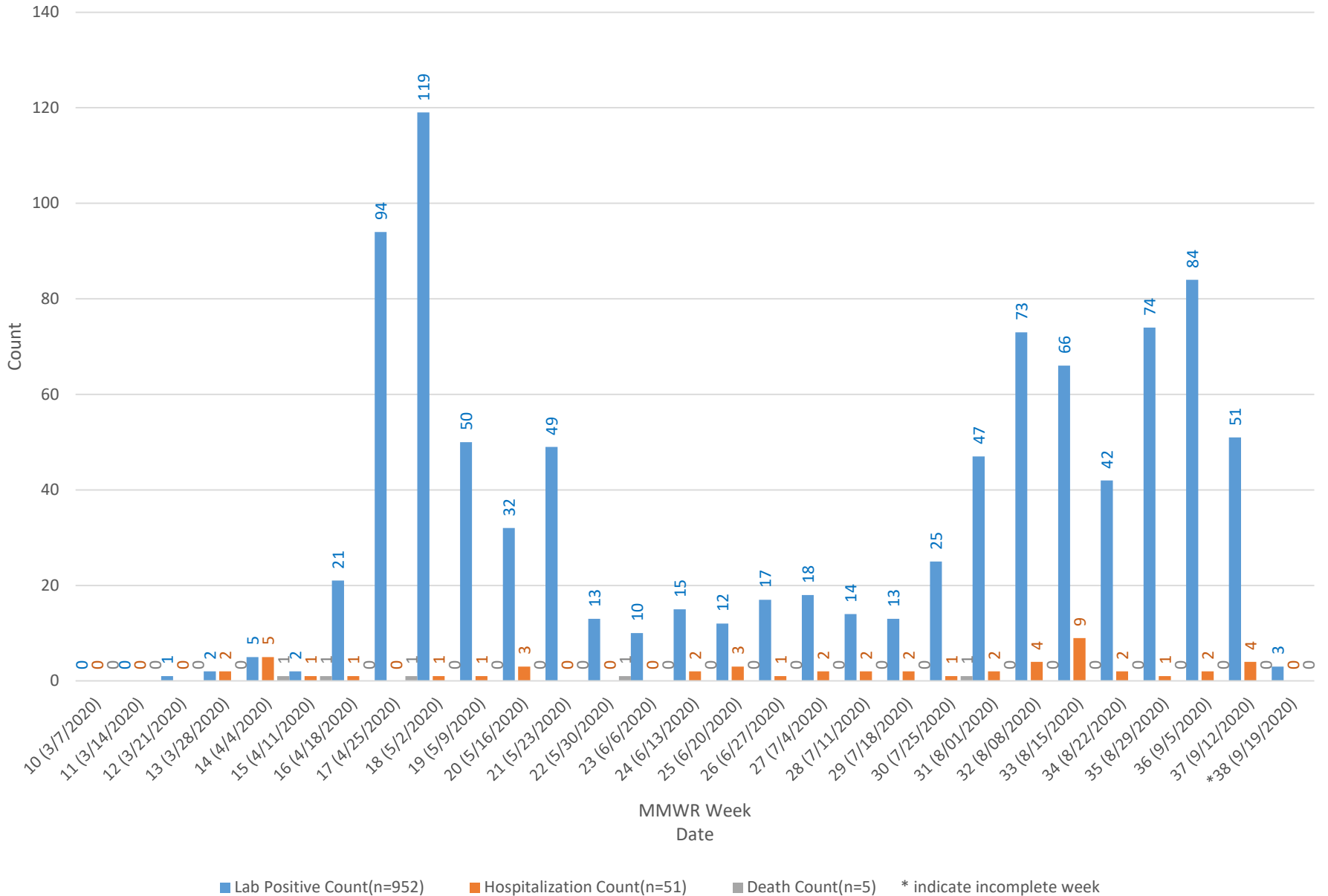

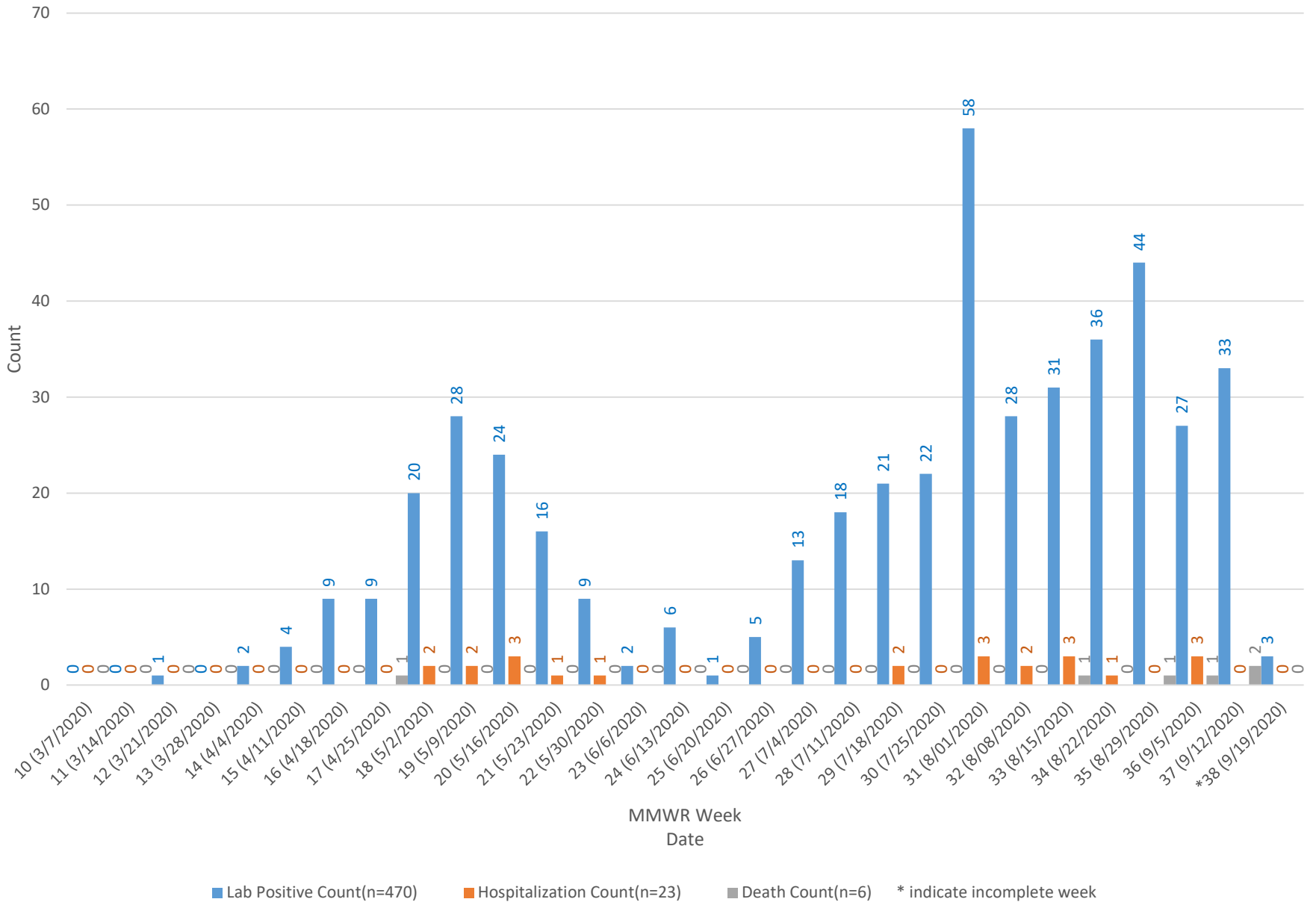

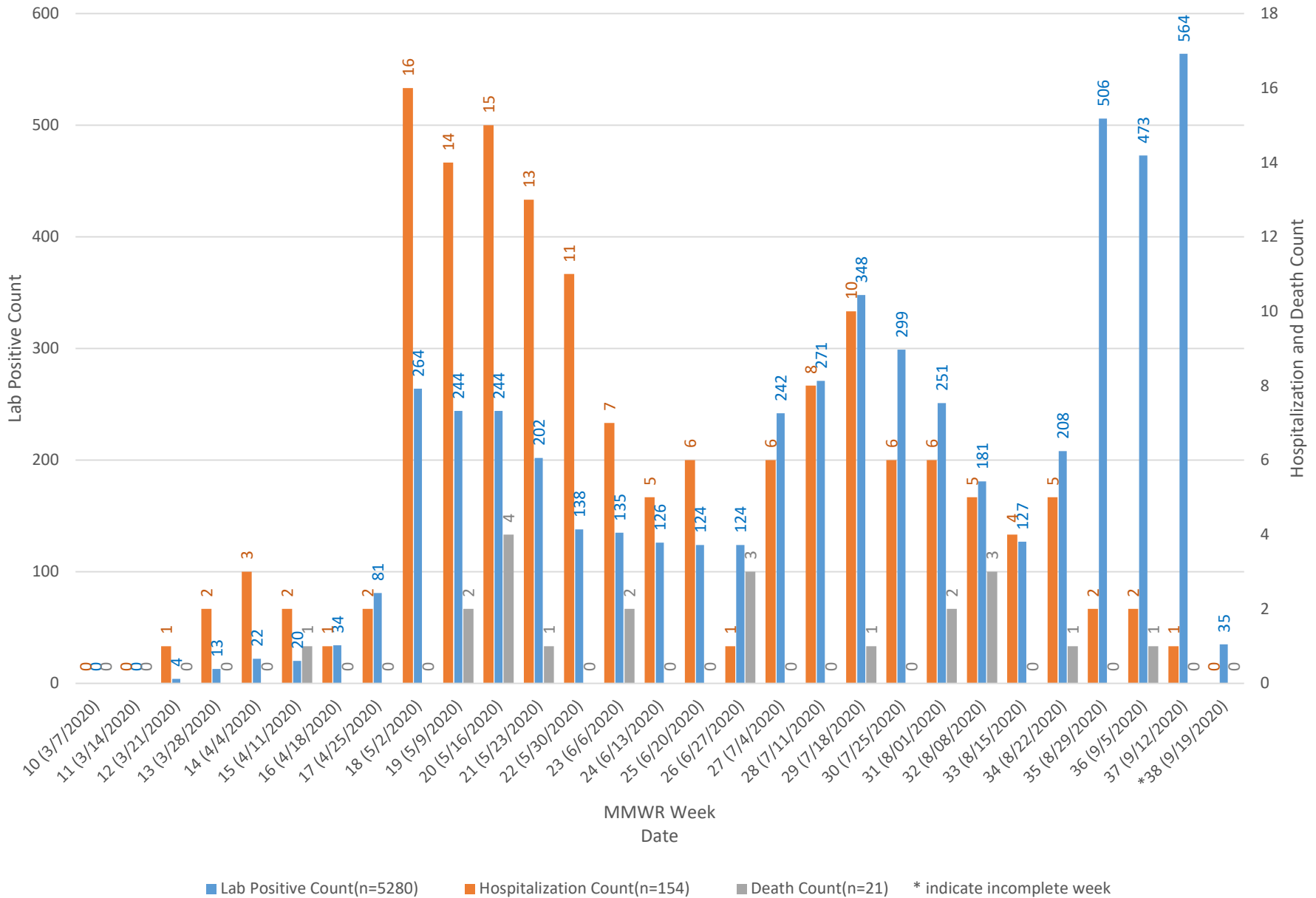

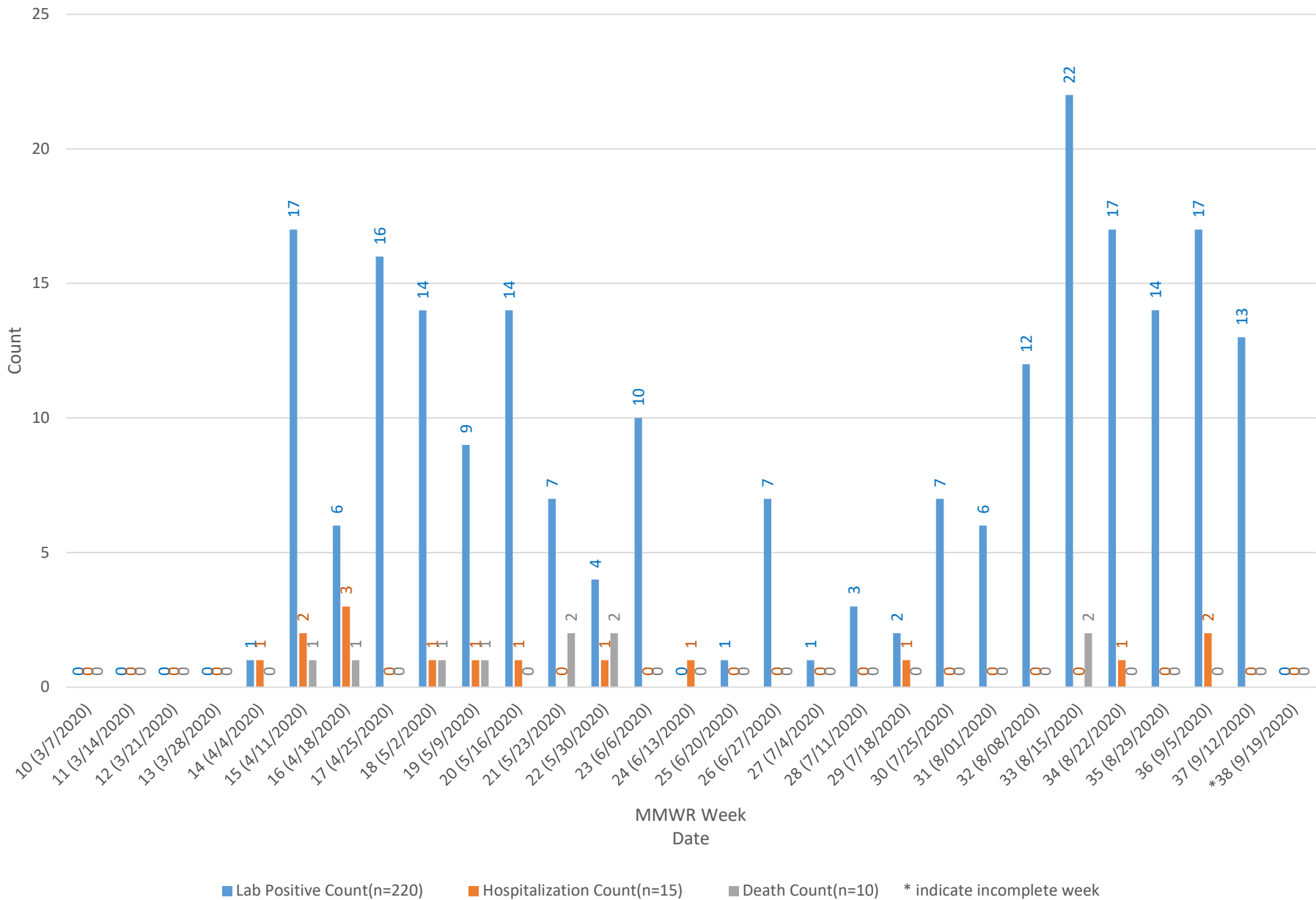
COVID-19 Lab Positive, Hospitalization and Death Count by MMWR Week, Four Corners Health Department, September 15, 2020



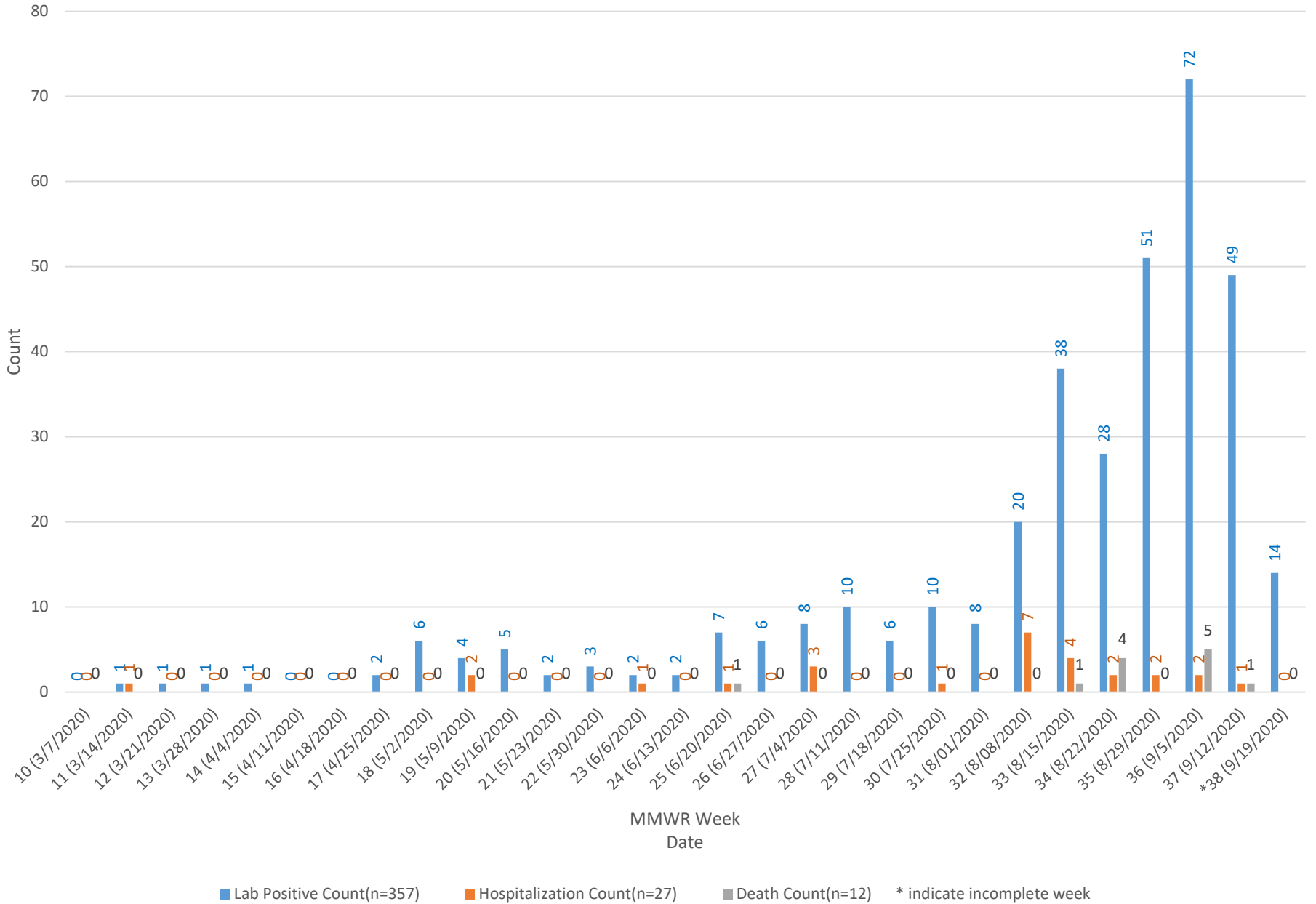

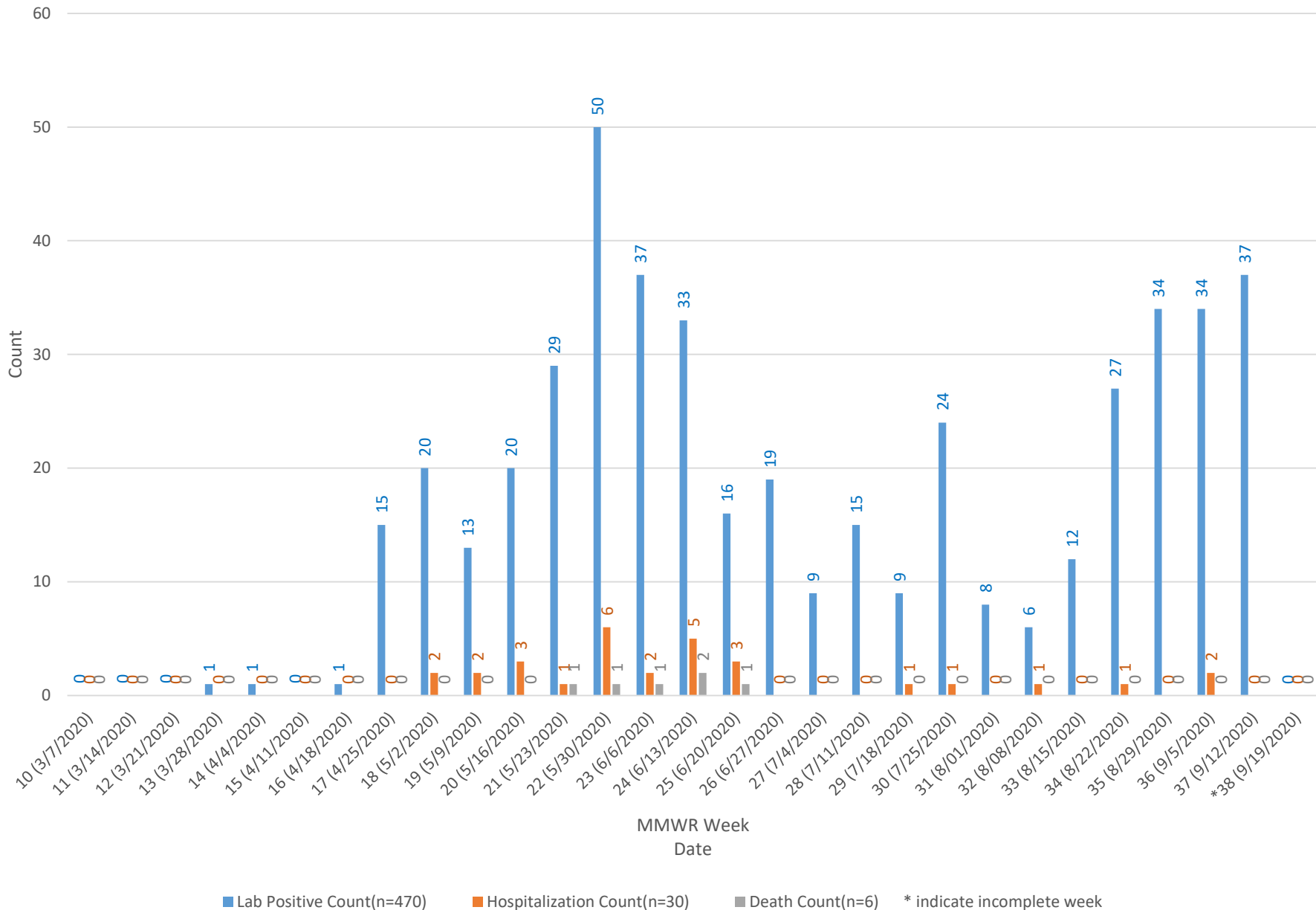

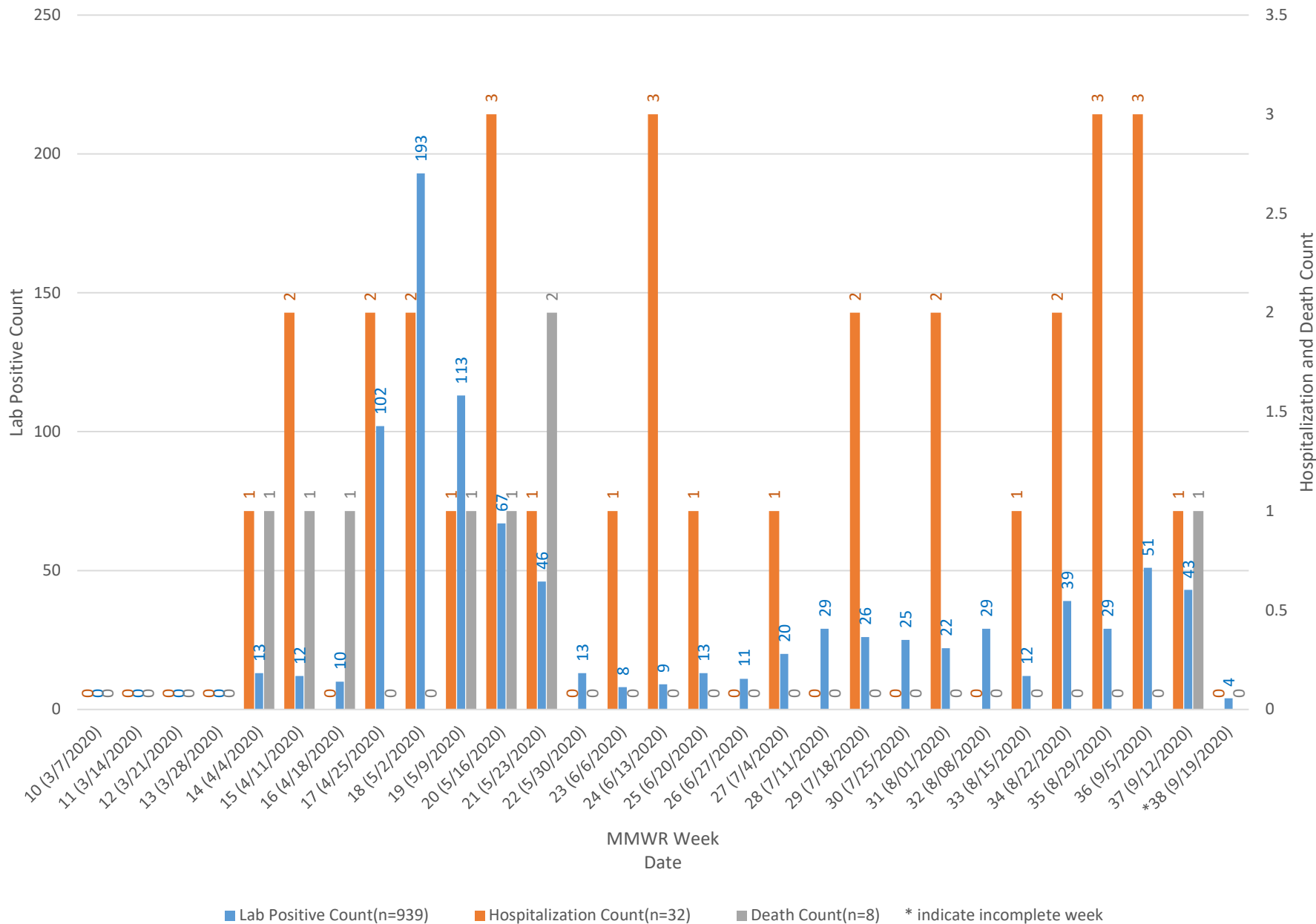

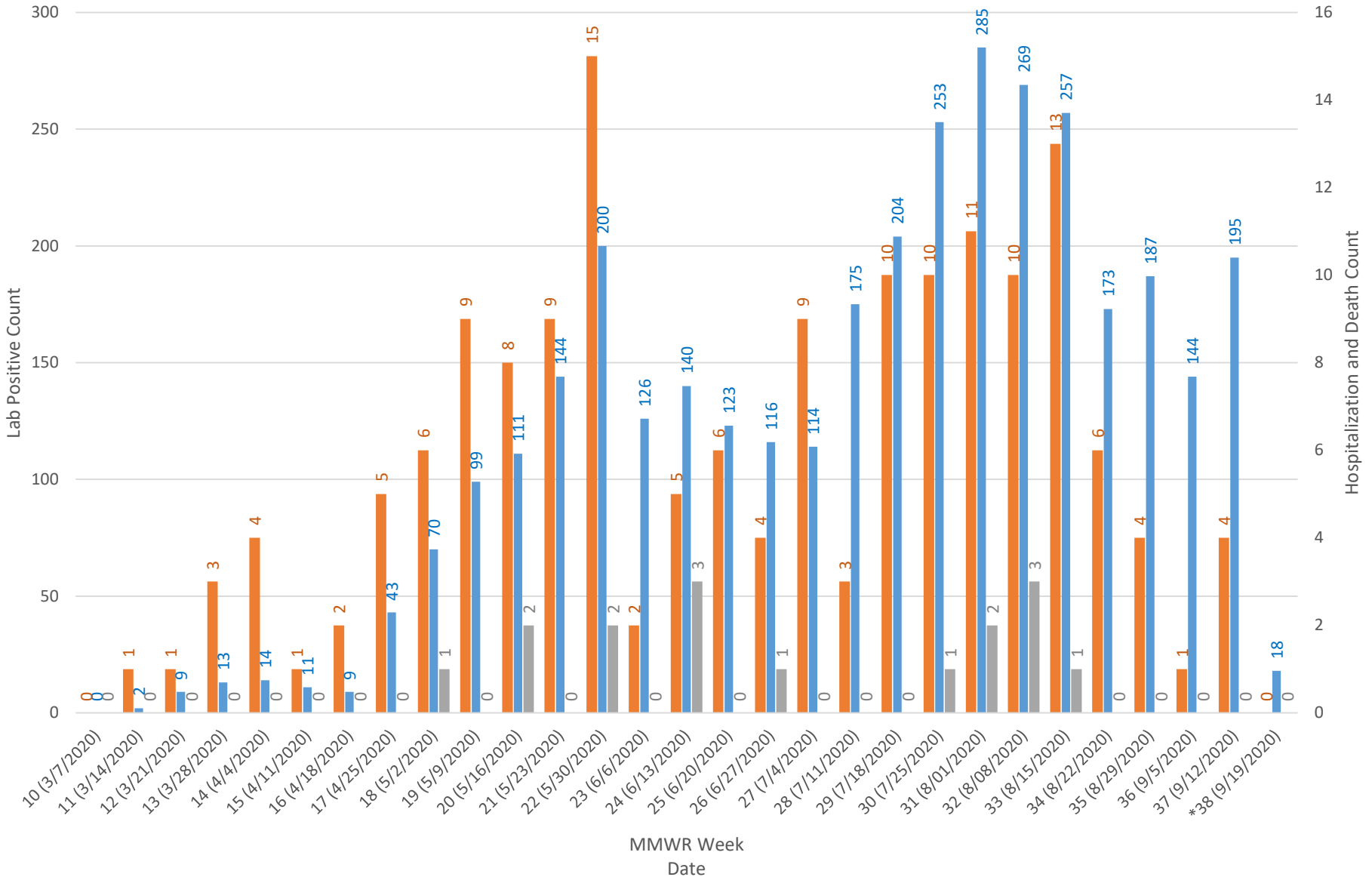

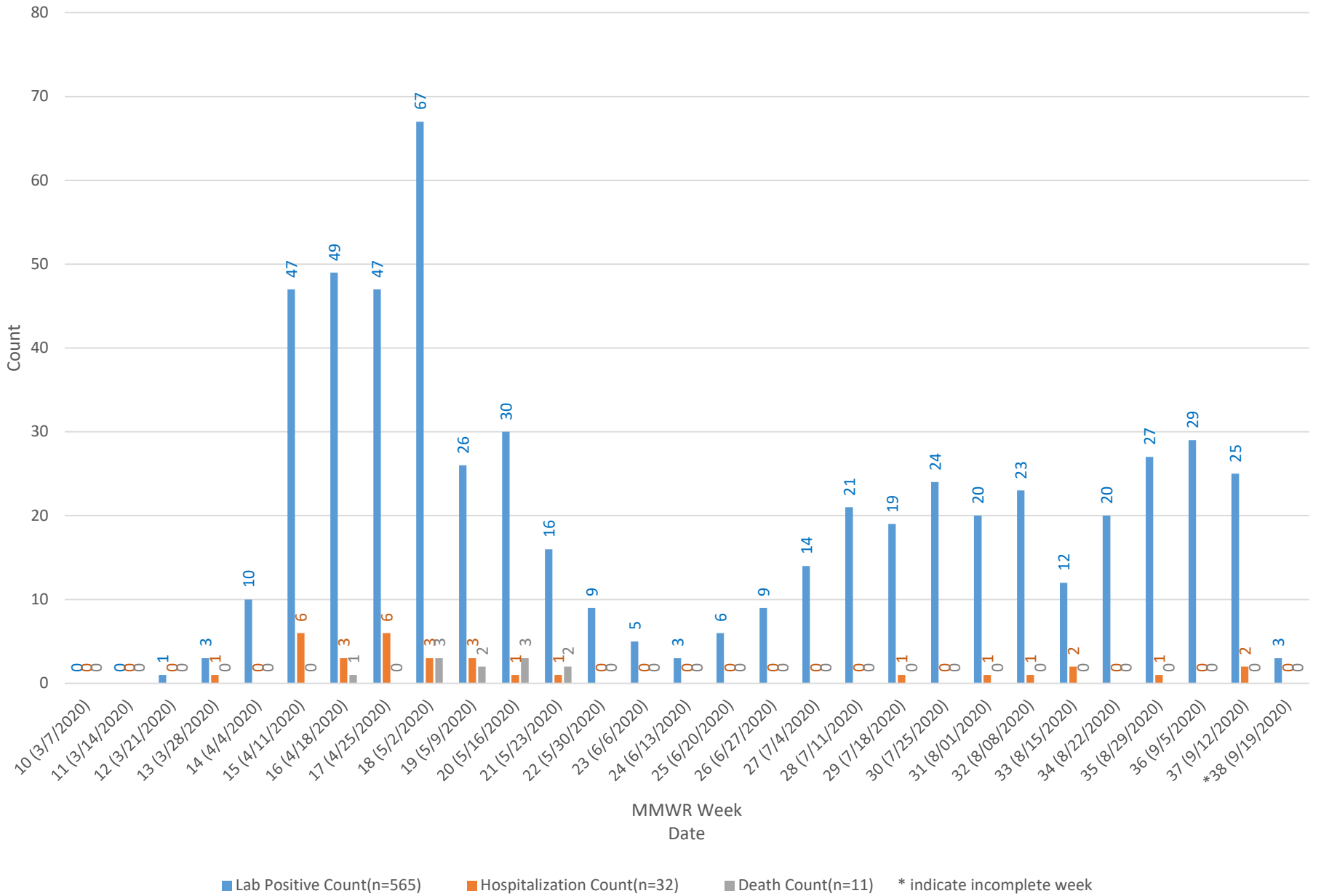

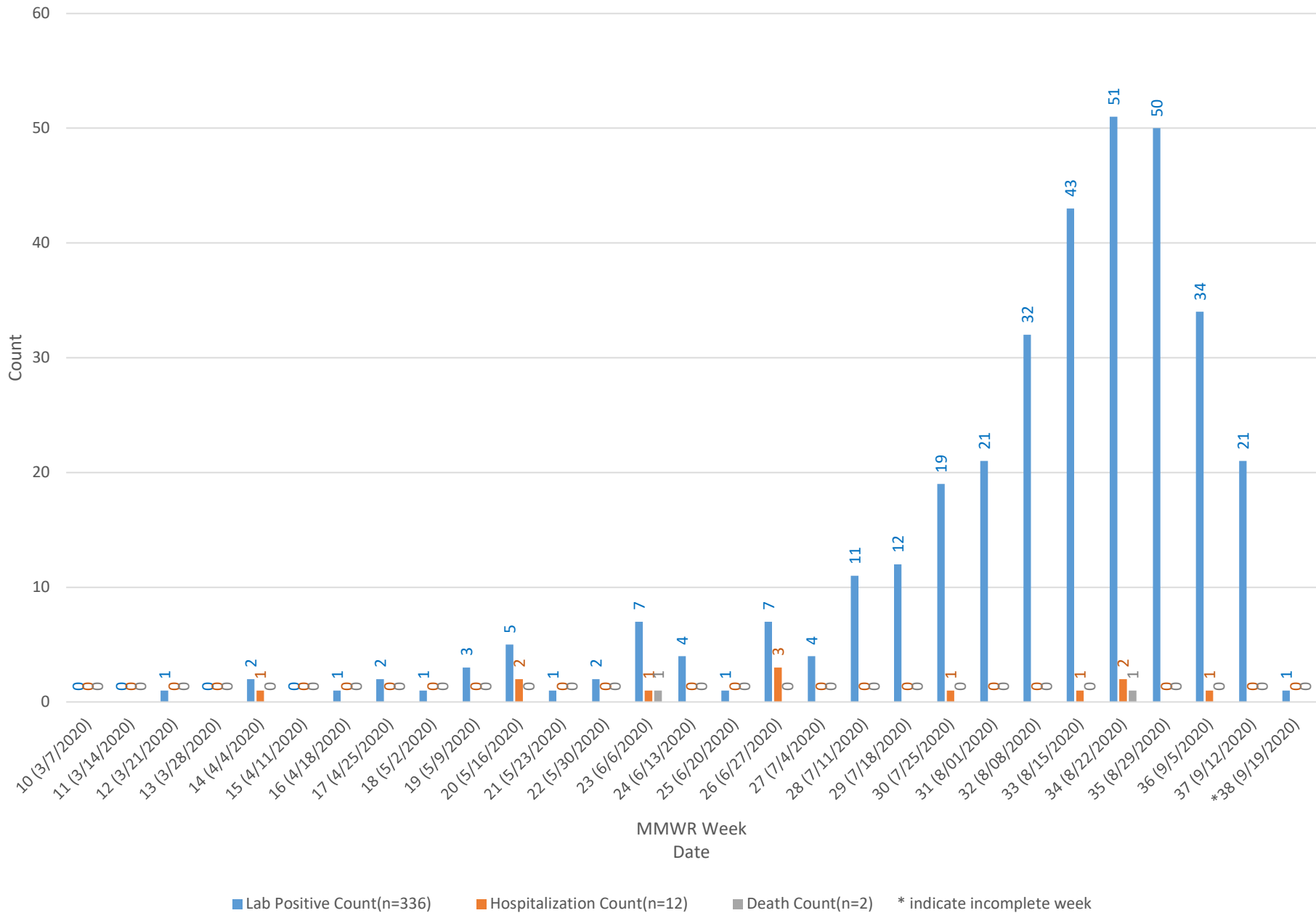

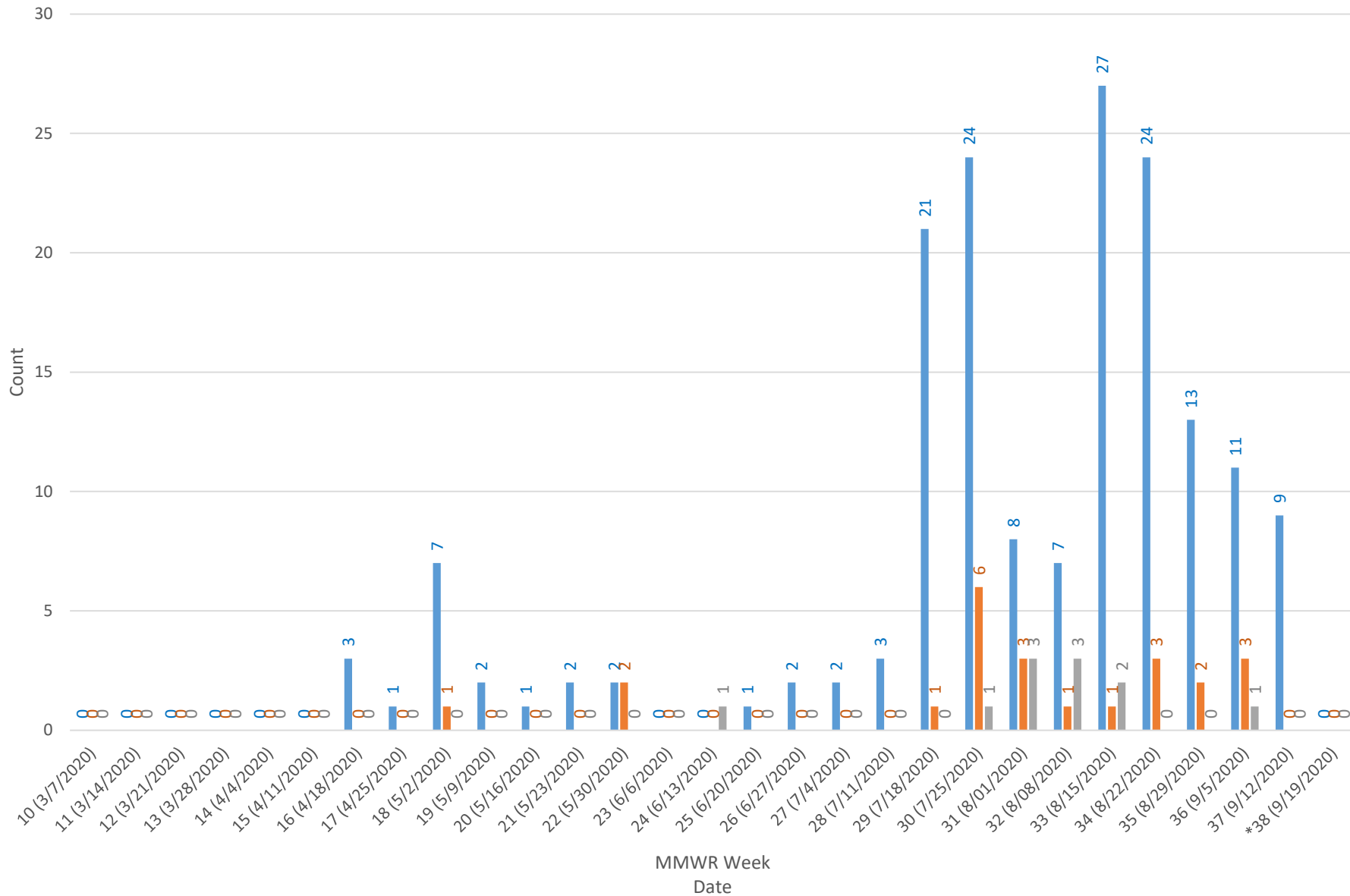
COVID-19 Lab Positive, Hospitalization and Death Count by MMWR Week, South Heartland District Health Department, September 15, 2020



COVID-19 Lab Positive, Hospitalization and Death Count by MMWR Week, Southeast District Health Department, September 15, 2020

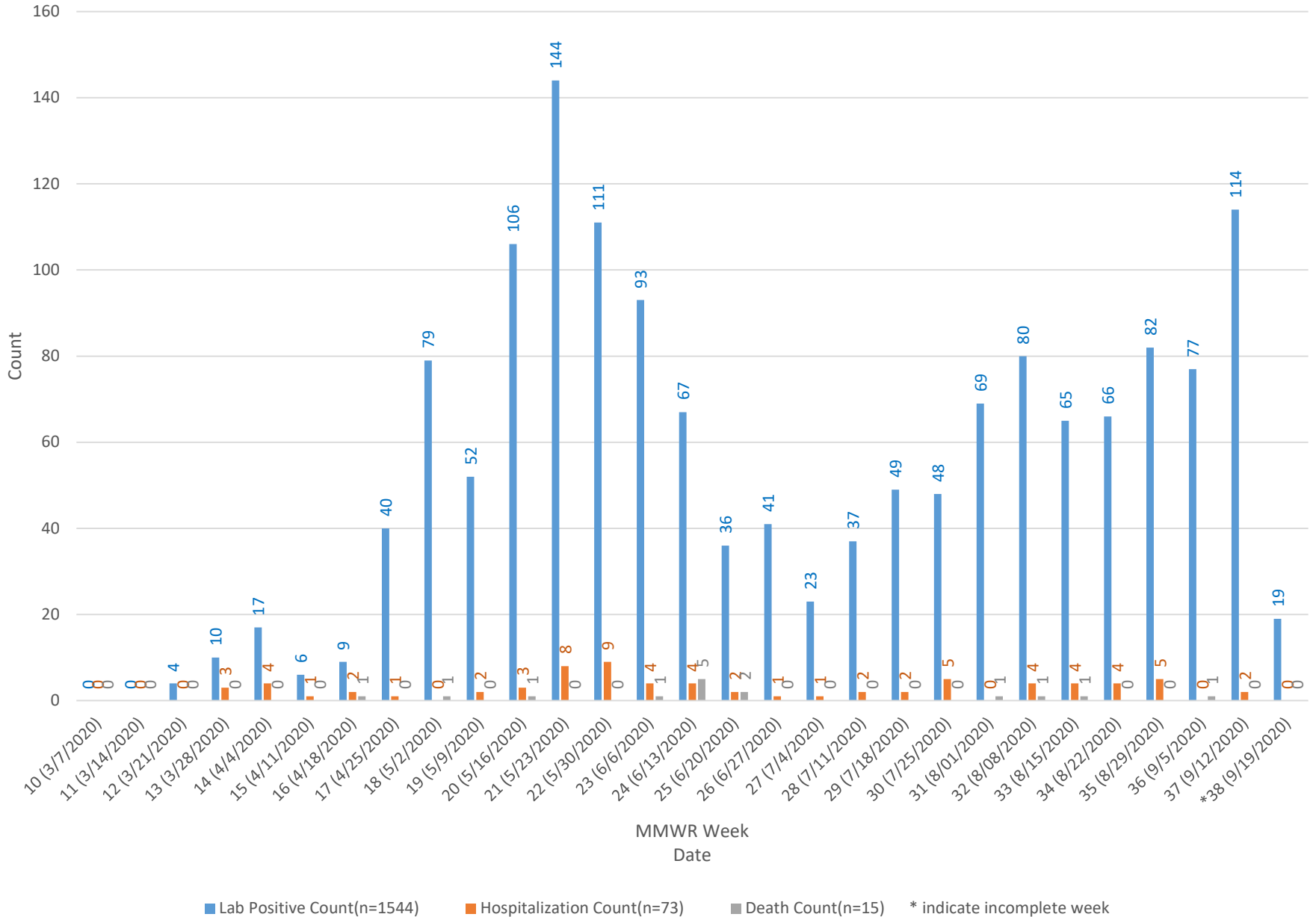

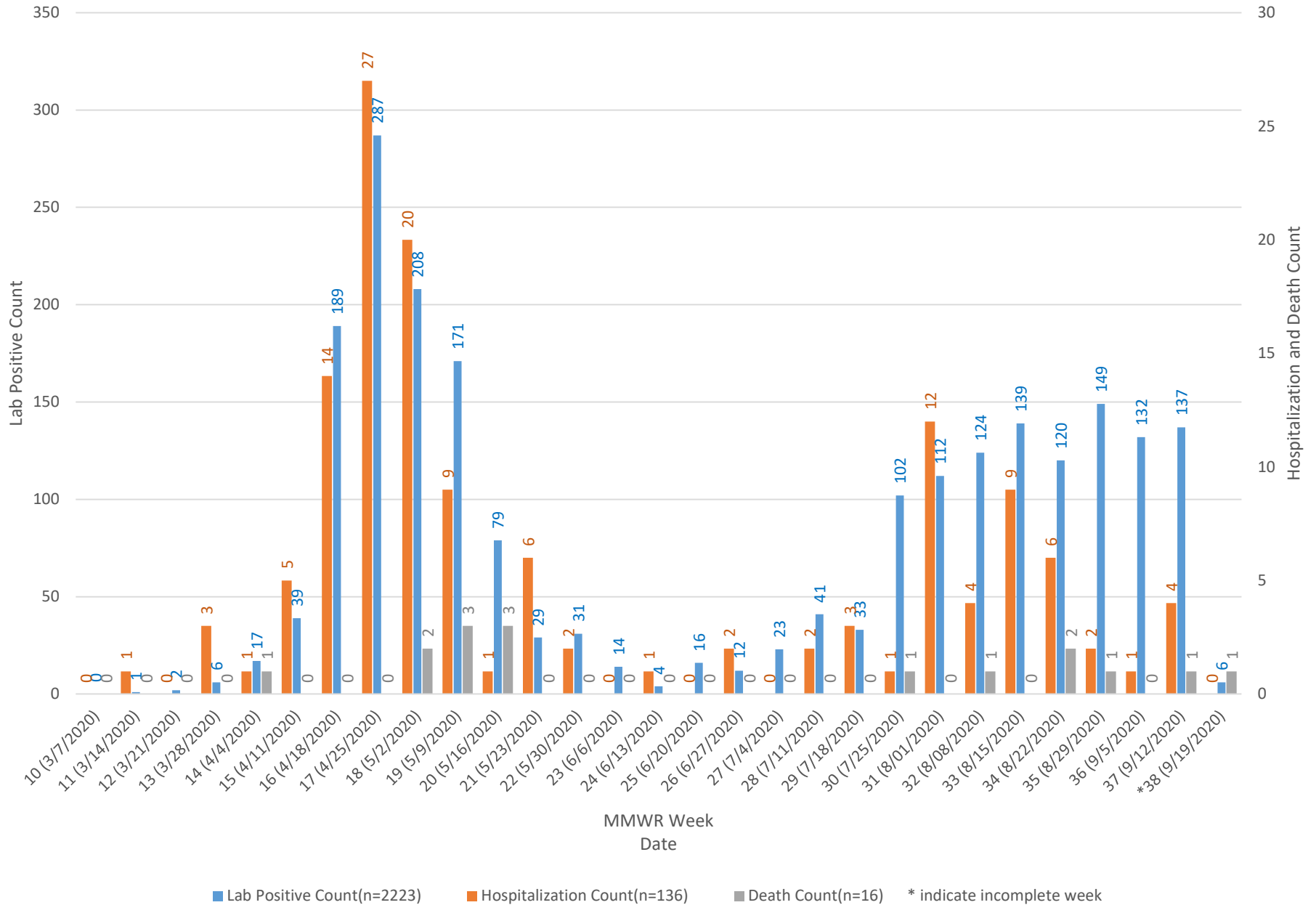

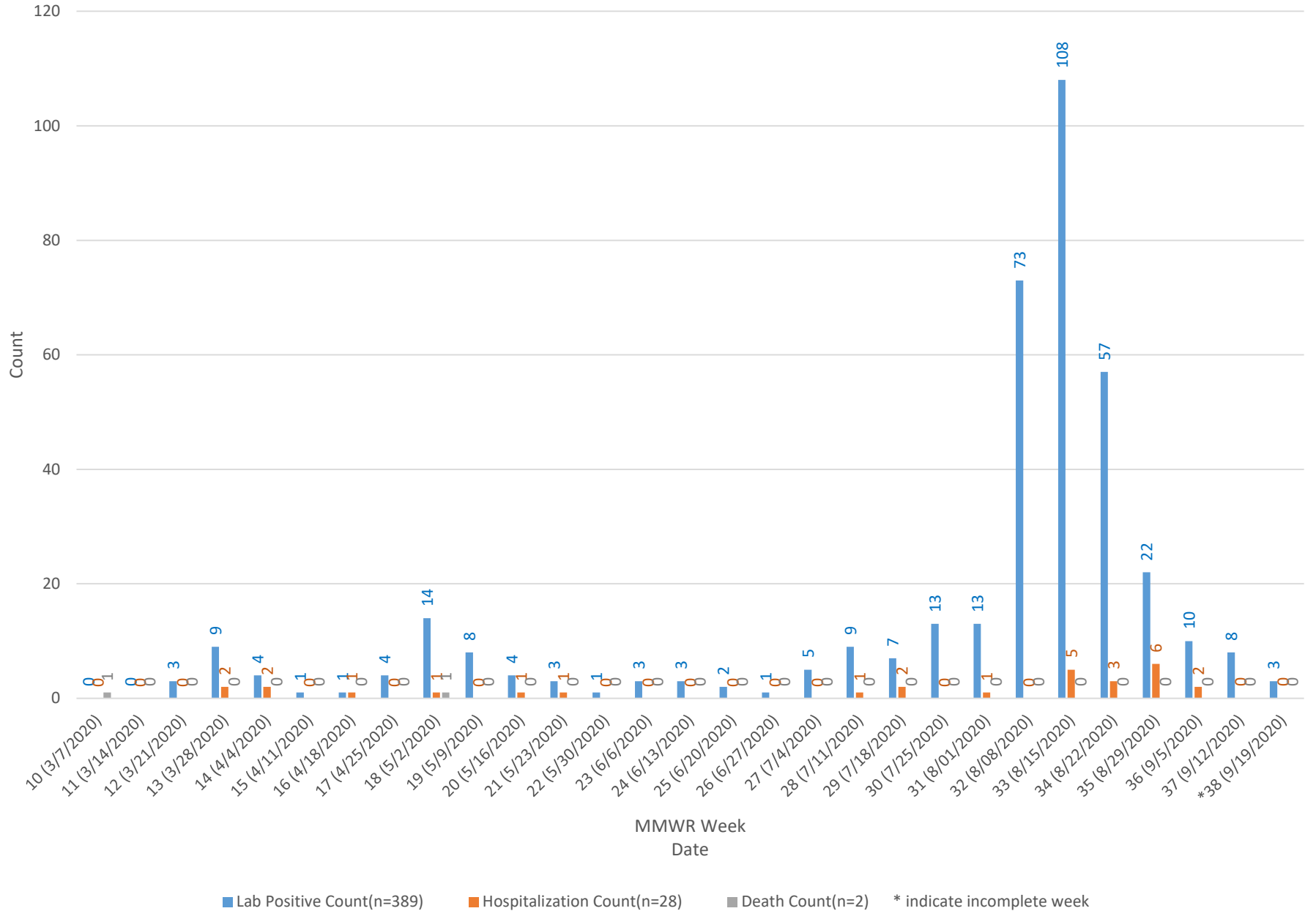

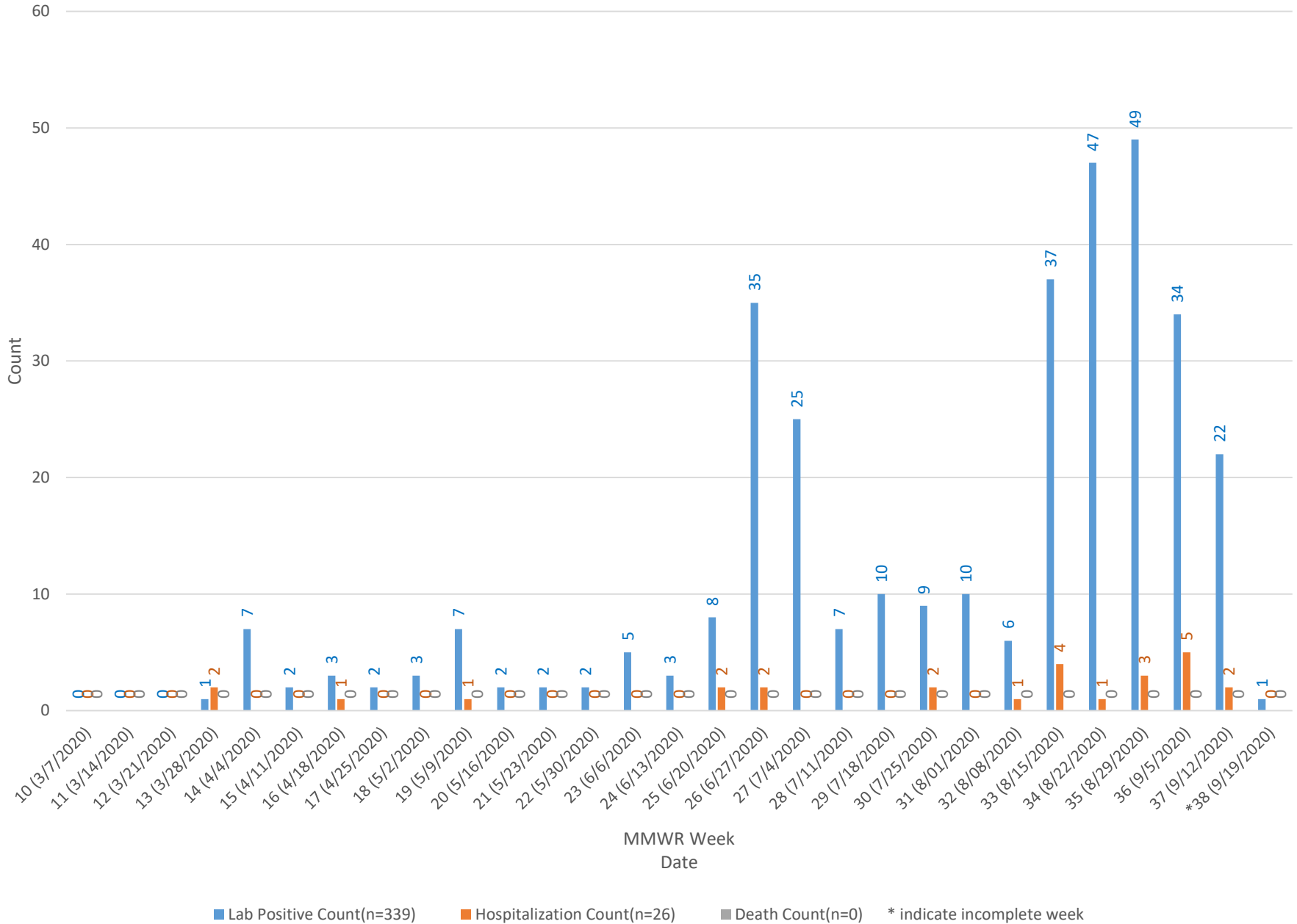
COVID-19 Lab Positive, Hospitalization and Death Count by MMWR Week, Two Rivers Public Health Department, September 15, 2020



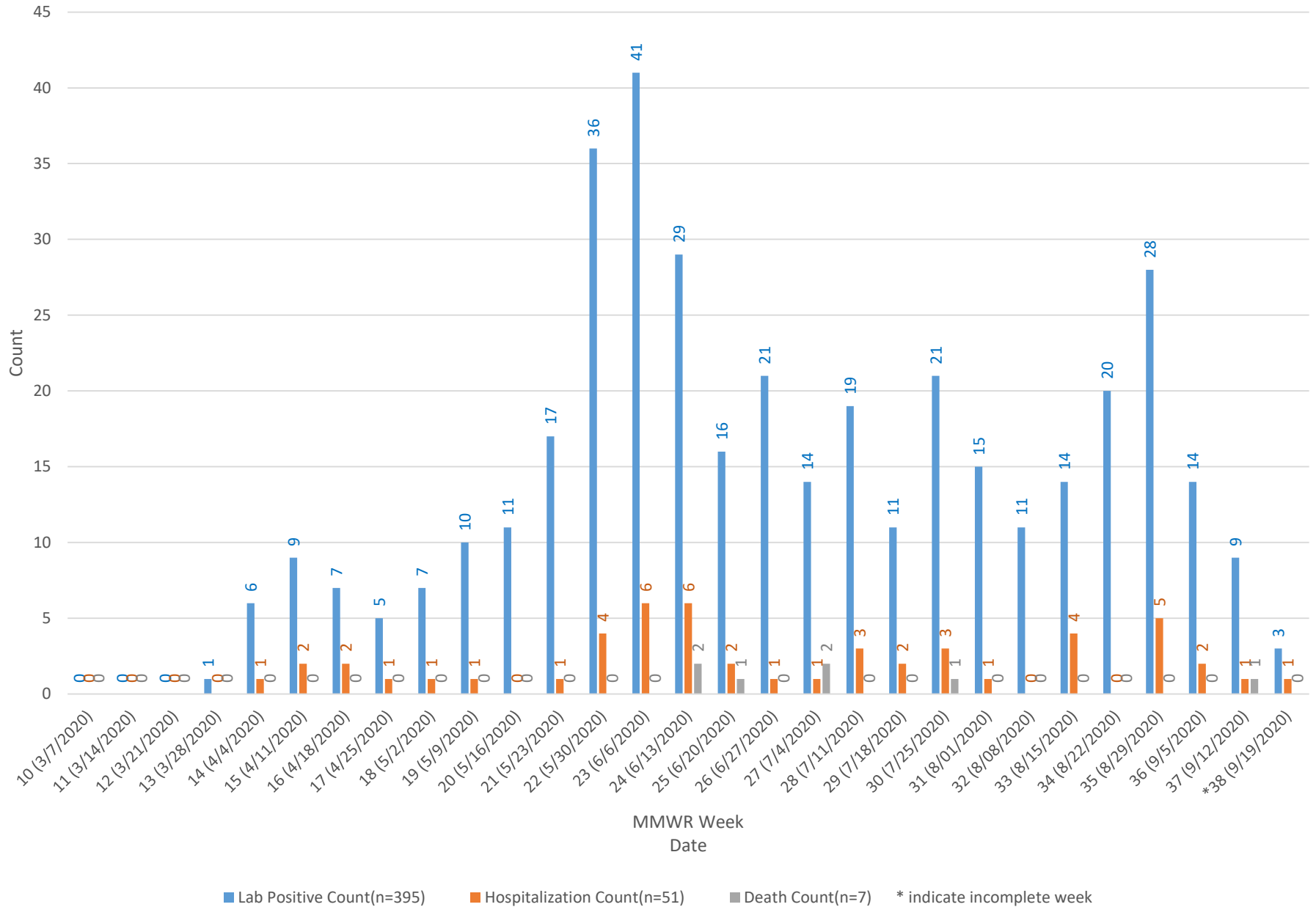
