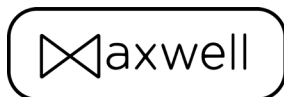

A RECIPE FOR THRIVING IN AN INDUSTRY TEETERING ON LIFE-SUPPORT

The nation's rural safety net health organizations have been conditioned to handle the pressure cookers of policy, payments, regulations, outmigration, and workforce shortages. Unfortunately, however, not unexpectedly, the 2020 public health crisis has turned up the heat, leaving many to wonder if it's time to get out of the healthcare kitchen.

During "A Recipe for Thriving in an Industry Teetering on Life-Support," Michelle Rathman shares the essential ingredients to reigniting, reengaging, and reinforcing the need to strengthen local systems of care and revive recruitment and retention initiatives left to boil over on the back burner.

What makes a community? Whether we're talking about a small town, a state, a nation, or the world, "community" implies a set of shared values, what we often call "the social contract." But America's social contract has been severely damaged by a number of forces acting over the past generation and a half. For his book, *Glass House: The 1% Economy and the Shattering of the All-American Town*, Brian Alexander took a deep dive into the story of one small Midwest community, an avatar for many American towns. In this presentation, Brian informs listeners about the history of Lancaster, Ohio, the rise of the post New Deal Town, and how the post-1980 change in American values created such distress in the "all-American town." His audience will learn about government policies, financial practices, and corporate dealing that actually encourage destruction of communities.

The nursing industry is facing a steadily growing shortage of clinicians. A recent report from the Institute of Medicine predicts that by 2030 we will have one of the largest shortages of nurses in history. The shortage has only been exacerbated by the pandemic, the Great Resignation, early retirement of tenured nursing staff, and a less than sufficient pipeline of nurses to sustain the ever-increasing demand. However, healthcare leadership can turn the tides of the nursing industry. To do so, they must create a sustainable pipeline of nurses and invest in employee development. This is achieved through short- and long-term strategies while keeping in mind that the best recruitment strategy is retention.

Attendees of this session will:

- Recognize ways for healthcare leaders to develop partnerships with academic institutions to close the gap in nursing staff long-term.
- Outline plans for the hiring process of clinical staff to be expedited and frequently reviewed.
- Identify the best long-term recruitment strategy as retention and professional development.

Rural hospitals have been plagued with outmigration and difficulty to remain profitable for decades. Physicians are also now less inclined to live or work in rural areas, making recruitment that much more difficult and expensive. There is also a nationwide shortage of physicians that is only adding to this problem. The temporizing measures that rural hospitals have been forced to employ to combat these issues are really only adding to them. Therefore, rural hospitals continue to close and mortality rates in rural communities are negatively impacted. We need to think outside the box to have a sustainable solution to this problem.

Innovation is the answer. We cannot continue to do the same models of over coverage and over paying for solutions that are not working. We break down what it takes to create these solutions and resources to assist along the way.

Attendees of this session will:

- Outline the current problem of outmigration and insufficient resources
- Outline solutions such as specialty medicine on a part time basis and how to maximize efficiency and productivity while helping consolidate limited resources.
- Discuss managing the OR with gain share opportunities to provide help with leadership development, OR management staffing and retention, increased engagement from staff and therefore success of program

CYBERSECURITY IN HEALTHCARE: MANAGING THREATS AND PROTECTING PATIENTS

In response to CSA Section 405(d), HHS established the HHS 405(d) Program, as the leading private-public collaboration center of the Office of the Chief Information Officer/Office of Information Security, program focused on providing the HPH sector with useful and impactful resources, products, and tools that help raise awareness and provide vetted cybersecurity practices, which drive behavioral change and move towards consistency in mitigating the most relevant cybersecurity threats to the sector. The 405(d) Program aims to develop consensus-based best practices and methodologies to strengthen the healthcare & public health (HPH) sector's cybersecurity posture against cyber threats. After significant analysis of the current cybersecurity issues facing the healthcare industry, the 405(d) Task Group developed Health Industry Cybersecurity Practice: Managing Threat and Protecting Patients, its first official Task Group product. The 405(d) Program and Task Group actively continues to develop new products to help further strengthen our sector. The HHS 405(d) program is also able to assist with many cybersecurity needs. Whether it's instituting a cybersecurity program structure using HICP, or educating staff on cybersecurity with our Knowledge on Demand Platform, the HHS 405(d) Program has it covered. On January 5th, 2021 PL 116-321 was signed to amend the Health Information Technology for Economic and Clinical Health Act (HITECH) which calls out "approaches promulgated under Section 405(d) of the Cybersecurity Act of 2015" as 'recognized security practices'. This is a step forward for public-private partnerships as it encourages HPH entities to bolster their cybersecurity posture by using industry tested best practices that can protect against cyber threats.

- Identify the top 5 threats facing the sector and learn how the top ten mitigating practices can mitigate them
- Explain how to leverage the HHS 405(d) Program's free cyber resources and education tools to assist them in keeping patients safe from cyber threats
- Identify ways in which the 405(d) program, once enveloped into an organizations culture, can provide continual cybersecurity tools, resources, and products to strengthen their cybersecurity posture.
