### **Finance**

The NHA Finance Department provides expertise to NHA members regarding financial policy issues by analyzing and communicating all significant reimbursement regulations and their impact, collaborating extensively with Nebraska's congressional delegation, Centers for Medicare & Medicaid Services (CMS), the Nebraska Department of Health and Human Services (DHHS), and other agencies/organizations as appropriate to influence financial policy and achieve reimbursement fairness.

#### **Revenue Cycle Residency Program**

Hospitals face a revenue cycle landscape that is growing in complexity. To address this challenge, we have developed the Revenue Cycle Residency Program. This program is intended to serve as an introductory residency for newer revenue cycle leaders or those interested in working in hospital revenue cycle. ## Data

The NHA collects and analyzes accurate and reliable Nebraska hospital health care and administrative claims data. The data is used for analysis and decision-making relative to the health care needs of the State of Nebraska and its residents. The NHA Dimensions Portal has various capabilities ranging from at a glance dashboards to the slice and dice tool allowing advanced users full customization by selecting their own elements and report layout. The Nebraska Hospital Association will continue its strategic role as a data aggregator for the NHA and Nebraska hospitals. In 2023, the Nebraska Hospital added the collection and aggregation of Rural Health Clinic claims data, a Predictive Analytics dashboard and a Health Equity – Social Determinates of Health dashboard.

#### **Analytics**

The Dimensions program allows members to select any combinations of claims data for analysis.

# Quality

The NHA Quality Team is dedicated to enhancing patient outcomes and safety in Nebraska's hospitals. They work on efficient processes, partnerships, and workforce development to ensure high-quality care. The team provides resources and services to support cultural changes and safety initiatives. They organize quality conferences, facilitating knowledge sharing and networking among members. Virtual learning cohorts allow interactive discussions on improvement and safety. One-on-one sessions provide personalized education and training. The team assists with quality improvement projects, offering planning and evaluation expertise. Consulting services and interim positions are available for program enhancement. The NHA Quality Team empowers hospitals to improve care, reduce costs, and deliver patient-centered excellence through collaboration and continuous improvement.

#### **CMS Quality Care Initiatives**

The NHA Quality Team engages directly with CMS supported quality programming that focuses on decreasing harm in the hospital, specifically in rural organizations. Through this program the quality team collects and analyzes hospital quality data, creates quarterly scorecards to trend performance while supporting hospitals in process improvement and education. #### **Quality Residency**

In partnership with the Rural QI Steering Council and the State Office of Rural Health, the NHA offers an annual 10-month quality training program. Sessions are focused on state and national quality requirements, building a robust quality program, and best practices for process improvement and sustainability. The NHA team has also developed a Quality Orientation Manual that serves as a reference to many key elements of health care quality programming. Staff contact: Dana Steiner

#### **Age-Friendly**

NHA has partnered with the AHA and IHI to bring the Age Friendly Care Model to Nebraska hospitals and communities. This model is focused on the spread of the 4Ms (mentation, mobility, medications & what matters) in the care of elderly patients. National certification is available to hospitals, nursing homes and clinics who complete the implementation process. Staff contact: Matt Lentz

#### **Statewide Quality Track**

The NHA is focused on education and performance improvement to allow for peer-to-peer learnings across the state of Nebraska. In partnership with Nebraska Department of Health and Human Services (DHHS) and the three Medicaid Managed Care Organizations, maternal health and safety will be a priority. Focused learnings will center on addressing maternal health deserts and access to care, preventing pre-term births, improving maternal and infant mortality, and addressing health disparities that may indicate increased risk of maternal safety challenges. #### **Data Council**

The purpose of the Health Information and Data Committee is to advise the NHA on the information needs of member hospitals and the data to be collected. It provides counsel on the format of data to be routinely disseminated to the membership and provides input on activities of organizations that impact members' data reporting activities such as accrediting bodies and various state and federal regulatory agencies. The Council guides and supports quality and performance improvement initiatives, evaluates results through engagement of quality data and ensures activities that will drive sustainability of effective changes. #### Transitions of Care Council

The purpose of the NHA Transitions of Care Council is to provide a forum for better understanding issues surrounding transitions of care and facilitation of improved coordination of care transitions across the health care continuum within Nebraska. The Council includes representation from the NHA Board, member hospitals, long term care and assisted living facilities, home health care, Department of Health and Human Services (DHHS) representatives and other stakeholders as identified by the Council. #### 340B Advisory Group

The 340B Advisory Group is comprised of NHA members who understand the issues and challenges surrounding the 340B Drug Pricing Program in Nebraska and nationwide. The purpose of establishing the 340B Advisory Group is to improve the performance and coordination in several key areas: (1) timely and accurate identification of issues of interest to the membership; (2) increased involvement of the NHA membership in 340B matters, both in identifying issues and influencing positions to be taken; (3) increased representation of state and national concerns; and (4) improved efficiency in allocation of NHA staff resources. #### Scope of Practice Advisory Group

The Scope of Practice Advisory Group is comprised of NHA members who understand the issues and challenges surrounding scope of practice in Nebraska. The COVID-19 pandemic demonstrated non-physician providers have played a critical role in the health care system. These providers helped lead the public health response through the pandemic and expanded their ability to help fill provider shortages, particularly in rural areas.

This Advisory Group examines ways for licensing boards to consider changes with non-licensed positions. We are looking at steps we can take at the legislature and with regulatory bodies that create and implement the rules and regulations. It is important for scope of practice to reflect a professional's true expertise. We need everyone practicing at the top of their scope. Staff Contact: Andy Hale

#### **Rural Emergency Hospital Consultations**

The NHA and Nebraska Rural Health Association (NeRHA) are utilizing DataGen, Inc.'s Rural Emergency Hospital (REH) analysis to predict the impact of Medicare Fee-For-Service (FFS) payment changes on Critical Access Hospitals and small rural hospitals. This analysis assesses the potential effect of transitioning from the current payment model to the new Rural Emergency Hospital (REH) payment. The NHA and NeRHA provide regional hospital and community education as requested, contracting with experts as needed. Both organizations act as the intermediary between interested hospitals and the RHRC for hospitalspecific analytics and feasibility studies. Staff Contact: Jed Hansen
